## For CHANCE trade promotion lotteries, you need a permit in:

Always, regardless of prize value Always for promotions where the prize pool exceeds \$3,000 Always for promotions with an instant win element, regardless of prize value. And, for drawbased promotions where the total prize pool exceeds \$5,000

Always for promotions where prize pool exceeds \$5,000 and no other authority has issued a permit No need to apply for a permit, however for promotions conducted by audio, visual or electronic media, the Ts&Cs must be lodged with the WA authority
