

# WHEN & WHERE IS A PERMIT NEEDED?

For CHANCE trade promotion lotteries, you need a permit in:

NSW

Always, regardless of prize value

ACT

Always for promotions where the prize pool exceeds \$3,000

SA

Always for promotions with an instant win element, regardless of prize value. And, for draw-based promotions where the total prize pool exceeds \$5,000

NT

Always for promotions where prize pool exceeds \$5,000 and no other authority has issued a permit

WA

No need to apply for a permit, however for promotions conducted by audio, visual or electronic media, the Ts&Cs must be lodged with the WA authority

## WHAT ARE THE PERMIT FEES?

From 1 July 2019, the permit fees are:
